The funds donated through ICASF help the Ingham County Animal Shelter Fund provide life-saving surgeries and treatments, such as tumor removal and heartworm treatment, as well individualized treatments that greatly improve each animal's quality of life.

Grants from Ingham County Animal Shelter Fund (ICASF)

The ICASF Grants fund projects to reduce the lifesaving gap of cats and dogs in U.S. shelters. We welcome project proposals from public and private shelters, rescue groups, and other animal welfare.

Your organization can apply for a grant of up to \$5,000, with the amount requested not exceeding 10% of your operating budget.

### **Requirements**

- Projects can be focused on just one event/program or can include multiple events/programs.
- Proposed projects should align with regional priorities. Projects that satisfy these priorities will have the largest impact on lifesaving in each region.
- We welcome project proposals from public and private shelters, rescue groups, and other animal welfare organizations that enable lifesaving.
- If awarded, the applying organization will need to submit a final impact statistic of how many lives were impacted through the project with the final report.

#### **Regional Priorities**

ICASF will make Ingham and Eaton County applicants a priority in grant funding to keep funding local, but will consider applicants outside of these Counties on a case by case basis.

#### Eligibility:

- Eligibility Requirements:
  - All applicants must be a non-profit or tax-exempt entity to apply
    - Programs must be implemented within Michigan.
    - Awarded grant funds must be spent within a one-year period.
    - A final report with impact numbers and outcomes must be submitted.
  - ICASF reserves the right to ask for clarification on any and all parts of the application before a final decision is made.

### **Animal Welfare Grant Information**

The Ingham County Animal Shelter Fund (ICASF) is offering grants to provide funds to:

- promote sterilization and adoption of dogs and cats
- improve knowledge of the proper care of animals pursuant to state animal anti-cruelty laws by educating the public and training personnel authorized by law to enforce state animal anti-cruelty laws
- to support and enhance programs that provide for the care and protection of animals pursuant to state anti-cruelty laws
- to allow the purchase of equipment and supplies for programs that receive grants
- and fund specialized veterinarian care for domestic animals.

#### General Eligibility Requirements and Grant Program Priorities:

• Funds will only be awarded to organizations that operate animal shelters currently registered with MDARD pursuant to Public Act 287 of 1969, as amended or non-profit rescue groups.

• ICASF Board Members are not eligible for any grant funds.

• An organization that has previously received an ICASF Grant that does not comply with the provisions or the terms of the Grant as determined by ICASF is not eligible for any future grants.

• The Ingham County Animal Shelter Fund will have final authority to approve or not approve grant proposals and awards, based upon selection criteria, program priorities, and the merits of the individual applications.

To apply for more than one program, an additional application must be submitted. Funding may be requested for the purchase of equipment, supplies, or services for any selected program.

### **CIRCLE ONLY ONE**

A. **SPAY/NEUTER SURGICAL PROGRAM** To increase the number of shelter dogs and cats that are sterilized and adopted by increasing the capability of on-site sterilization or by facilitating appointments for sterilization by a licensed veterinarian.

• Funds in this category may not be used to sterilize privately-owned dogs and cats nor be used to sterilize dogs and cats imported into Michigan by rescues or shelters.

• Funds in this category may not be used for ancillary procedures such as vaccination, micro-chipping.

B. **PUBLIC EDUCATION PROGRAM** To improve community knowledge of the value of sterilization and adoption of dogs and cats, and/or improve community knowledge of the proper care of animals pursuant to state animal anti-cruelty laws.

• These programs may be implemented through educational programs or creative media opportunities. Opportunities may include but are not limited to billboards, printed materials, presentations, booths, educational programming, and/or digital media creation.

C. **TRAINING FOR AUTHORIZED PERSONNEL PROGRAM** To improve knowledge of the proper care of animals pursuant to state animal anti-cruelty laws by training personnel authorized by law to enforce state anti-cruelty laws. Opportunities may include but are not limited to training program registration fees, speaker fees, and/or facility costs associated with hosting a training conference.

• Funds may not be used for attendees' or speakers' travel, lodging, or meal expenses.

• ICASF must approve conferences, workshops, training for attendees, as well as the agenda and speakers for any hosted training conference.

D. **EQUIPMENT PURCHASES** To purchase equipment specifically to help with spay/neuter, TNR or other programs that will help increase the number of shelter dogs and cats that are sterilized and adopted in Ingham and Eaton counties.

• Equipment should be stored and used by the grantee.

• Equipment is not for personal use.

E. **CARE AND PROTECTION PROGRAM** To support programs that provide for the costs of care for animals that are housed for violations of state animal anti-cruelty laws, and/or programs that support the proper care and protection of animals pursuant to state animal anti-cruelty laws.

• Funds may not be awarded if court sentencing provides for all applicable animal care restitution costs to the grantee.
